

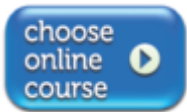

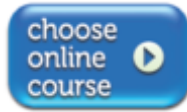


## Queensland (Qld) do Accept Online RSA Certificates

All new staff employed after 1 January, 2009 are required to complete an OLGR approved RSA course within 30 days of commencing employment. **Our QLD RSA online course and bridging course is suitable** for new staff or RMLV staff training and is OLGR approved. 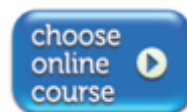

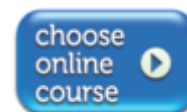


## Northern Territory (NT) do Accept Online RSA Certificates

## South Australia (SA) do Accept Online RSA Certificates

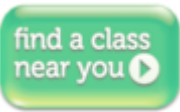

You need to apply to the SA Liquor Licensing Commission to be a **responsible person**, part of this process will be to supply evidence of the national RSA certificate, which can be done online with us. **New South Wales (NSW) Only Accept In Class RSA Training**

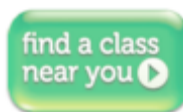
